The Event shall be a **National Historic** Race Event held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsport Australia, The Circuit Race Standing Regulations (CRSR), the Regularity Trial Standing Regulations, the Supersprint Standing Regulations, the Historic Standing Regulations, the Technical Regulations for 5<sup>th</sup> Category Historic Cars, these Supplementary Regulations and any Further Supplementary Regulations, Bulletins and / or Instructions issued for the Event.

The Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found on the Motorsport Australia website at <a href="https://www.motorsport.org.au">www.motorsport.org.au</a>

## 6. ENTRIES | DETAILS

- a. Entries open on publication of these Regulations and close on **August 15 2025**. Entry fee is \$550 per entry. Entries received without the correct entry fee will NOT be included in the acceptance process. **PLEASE NOTE**: As the Motorsport Australia member portal entry system is used to administer this Event, Competitors are asked to lodge entries at <a href="https://www.motorsport.org.au">www.motorsport.org.au</a>. Alternatively, traditional entry forms are available by request to <a href="mailto:noelbryen@gmail.com">noelbryen@gmail.com</a>.
- b. Competitors passes for this Event. **NOTE:** Competitors will be automatically issued with 2 passes. Additional passes will be provided if requested up to a maximum of 4. Should any competitor require more than 4 passes, they can be purchased for \$30 each. All passes will be available for collection from the Competitor & Event Registration Office at the circuit from Friday 31 January 2025 from 1:00pm.
- c. Motorsport Australia member portal entry or Paper Entry Form must be completed in full, accompanied by the correct payment and lodged prior to the Event. The Organisers reserve the right to refuse any entry in accordance with the NCR. PLEASE NOTE MAILING ADDRESS for paper entry forms and payments is as follows; HSRCA 2025 Goulburn Historics/PO Box 1774 / Warriewood, NSW 2102. - d. All cheques (no cash through the mail please) are to be made payable to the **Historic Sports & Racing Car Association of NSW Inc.** and are not considered received until honoured. A fee of \$50.00 shall apply for a dishonoured cheque.
- e. Notification of withdrawal to be advised through the Motorsport Australia Online Entry portal (as with entries).
  - i. Prior to 7 days before the event (5.00pm Friday 22 August) a full refund less \$50.00 administration fee.
  - **ii.** Within 7 days of the start of the event (after 5.00pm Friday 22 August). Entry fees will be refunded less \$50 administration fee. However, garage, carport and marquee hire fees **will not** be refunded.
  - iii. All refunds will be subject to a \$50 Admin Fee.
- f. All communication with Competitors after receipt of entries will be by email or HSRCA website notice. Those without access to email should advise the Secretary of the Event, or administrative secretary, so that alternative arrangements can be made.

#### 7. EVENT SCHEDULE

- a. It is proposed that over the two days of the Event, all cars will have one practice/qualifying session plus at least three (3) Races.
- b. It is proposed that over the two days of the Event, Regularity and Supersprint cars, will have one practice session plus at least three (3) Trials or Sprints.
- c. The number of races, trials and sprints will be based on group preferences and designed to provide equivalent track time. Therefore, sprints may have more track sessions than some race classes.
- d. The program may include handicap races.
- e. A minimum lap time of 1 minute 12 seconds shall apply to Regularity Events.
- f. The Event Schedule will be advised with Further Supplementary Regulations.
- g. The Stewards may reduce the number of laps for a race, trial or sprint based on time constraints.
- h. Feature groups to be included in this Event are to be advised.
- i. As this is the first Race Event to be held since the circuit has been re-built, some delays may occur due to the testing and verifying of all of the necessary protocols.

## 8. AWARDS

a. Trophies shall be awarded at the discretion of the Organiser.

## 9. SCRUTINY | PRACTICE | GRID DETERMINATION

- a. Targeted scrutiny will be in operation at this Event and vehicles that are part of this program are required to bring evidence of such to the Scrutineers in the form of a documented logbook. Vehicles which are yet to have their initial targeted scrutiny audit shall be required to undergo initial scrutiny. Motorsport Australia Self-Scrutiny Forms must be downloaded, printed, completed and brought to the Scrutineers.
- b. Scrutineering and document check will take place at the circuit on Friday 29 August 2025 between 1:00pm and 5:00pm and on Saturday 30 August 2025 from 7:30am. On Sunday 31 August 2025 a minimum of a safety check may take place.
- c. **Required Documentation** is requested to be **printed by the Competitor**. These are available on the HSRCA website, completed as required and present at document check. Vehicle logbooks and Certificates of Description (where applicable) shall be presented at Scrutiny.
- d. Markings on all race vehicles must comply with the Vehicle Eligibility General Requirements for 5<sup>th</sup> Category Historic Cars and Technical Appendix Schedule K of the Motorsport Australia Manual.

The livery on all Supersprint and Regularity vehicles must represent the era the vehicle is demonstrating. The Promoter reserves the right to refuse any entry that does not comply.

- e. Driver & Crew APPAREL shall be in accordance with Technical Appendix Schedule D of the Motorsport Australia Manual
- f. Timed Qualifying / Practice shall take place on Saturday **30 August 2025** and will be the qualifying basis for determining grid positions for the first race.
  - i. Grid positions for subsequent scratch races for all groups will be determined by the finishing order of the preceding race (with non-finishers and non-starters being added at the rear of the field at the discretion of the Stewards).
  - ii. Grid positions for Trophy Races, or races where groups are divided or split, shall be determined by Qualifying.
  - iii. The Organiser reserves the right to vary, combine, or add to practice sessions, subject to the approval of the Stewards.
- g. Rolling starts may be used for selected races. These will be detailed in the Further Supplementary Regulations.

#### **10. LICENCES** (INCLUDING INTERNATIONAL DRIVERS)

- a. **Racing** Drivers must hold a minimum of a current Motorsport Australia Circuit Licence with Provisional endorsement unless specified otherwise below.
- A driver must hold a minimum of a Circuit Licence with an HPL Endorsement to compete in the following 5th Category vehicles:
  - i. FIA Formula One vehicle in Group O,P,Q,R;
  - ii. Indy Car vehicle in Groups O,P,Q,R;
  - iii. Group F5000;
  - iv. Formula 3000 in Group R
  - v. Formula Holden in Group R
  - vi. Group O, P, Q & R Sports with engine capacity over 3 litres normally aspirated or over 1.8 litres forced induction;
  - vii. FIA Group C1 & C2 Prototype; and
  - viii. any vehicle deemed to be of a performance level requiring an HPL as determined by the Historic Motorsport Committee

**NOTE:** A driver holding an International licence must also have an HPL Endorsement to compete in any of the above vehicles in a Motorsport Australia circuit race competition up to National Championship

- A Circuit licence without Provisional endorsement will be the minimum requirement for the following 5th Category Historic vehicle Groups:
  - Any vehicle requiring an HPL;
  - FIA Formula 2 in Groups Q & R;
  - Sports over 2000cc in Group Q & R
- b. Regularity & Supersprint Drivers must hold a minimum of a current Motorsport Australia Speed Competition Licence.
- c. All Drivers must have proof of current membership of a Motorsport Australia affiliated Club.
- d. No licences will be available for issue at the Circuit.
- e. All Licences, Motorsport Australia pass books, competition records and Club membership cards must be available if required for inspection at any other time during the course of the Event.
- f. Motorsport Australia Vehicle log books, Historic Technical Passports (HTP), and Certificate of Descriptions (COD) must be presented at **Scrutiny** and be available, if required, for inspection at any other time during the course of the Event. Scrutineering will take place in the Scrutineering Bay.

Each Competitor and Driver must hold a Motorsport Australia Competition Licence as listed above unless they comply with (a) or (b) below.

- (a) hold a Motorsport New Zealand competition licence and Tasman Visa valid for the Event; or
- (b) hold a minimum of the highest grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the Event; each such Driver and Competitor:
- (i) shall be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the Event; and
- (ii) must receive an authorisation to compete from Motorsport Australia prior to the Event;

The Organiser confirms that the Circuit to be used for this Event holds the necessary Motorsport Australia National Track licence for each of the competitions nominated in these Supplementary Regulations.

#### 11. DRIVERS BRIEFING

Compulsory Driver Briefing shall be held on Saturday 30 August 2025 at 08:15am in front of the Control Tower.

#### 12. CHANGE OF DRIVER

A change of driver may be permitted as per the NCR & CRSR. See the Secretary of the Event if a driver change is required.

#### 13. NOISE EMISSION

In accordance with Technical Appendix - Schedule B of the Motorsport Australia Manual, each competing vehicle must be configured such that the sound emitted when measured 30 metres from the track edge does **NOT exceed 95dB (a)**. Note that this will be strictly enforced by One Raceway. Competitors who are black flagged will be given one opportunity to rectify the problem and if this fails then they will be excluded from the Event.

#### 14. CHANGE OF PROGRAMME

The Organiser reserves the right to vary the programme under the CRSR and the NCR.

#### 15. JUDGES OF FACT

- a. The Judges of Fact in respect of the start / finish and noise emission shall be the Clerk of the Course, Deputy and Assistant Clerks of the Course, Secretary of the Event, the Chief Timekeeper, the Chief Scrutineer, the Starter and Assistant Starters.
- b. Judge of Fact for pit lane speed and exceeding track limits shall be the Post Chief as listed in the daily personnel report.
- c. The Judges of Fact will be named in the Further Regulations.

#### 16., POSTPONEMENT & STOPPING

The Organiser reserves the right to postpone or stop the Event in accordance with the NCR.

#### **17. DRIVER BEHAVIOUR**

All Drivers are subject to CRSR Article 6 Code of Driving Conduct and Driving Standards of the Historic Standing Regulations. Should a driver be deemed to be in breach of these regulations, disciplinary action may be taken.

## 18. TIMING | LAP SCORING

- a. Timing will be by the Mylaps electronic system only and will be the official record of lap times and number of laps completed. Transponders will be available at the circuit FREE OF CHARGE through Eldee Timing: Contact Lisa Drayton 0402 830 313 or lisa@eldeetiming.com.au for any queries. The LAST LAP board will be in use at this Event.
- b. Distribution of Results will be via <a href="http://racing.natsoft.com.au/results/">http://racing.natsoft.com.au/results/</a>

#### 19. RACE STOPPAGE | RED FLAG

Should a race be stopped by the use of the Red Flag all vehicles are to return to the pitlane for instructions. Should a Race be abandoned it may be rescheduled if time permits. The grid will be determined in accordance with the CRSR. Should the Race not be restarted, it shall be deemed to have finished and the results shall be in accordance with the CRSR.

#### **20. FIRE EXTINGUISHERS**

- a. Competitors may be required to pay for the servicing of any fire extinguishers used on their vehicle.
- b. Each Race Competitor must provide at least 1 operable 4.5kg ABE Powder fire extinguisher for their paddock or pit area in accordance with the CRSR.

## **21. FUEL**

- a. Fuel must be in accordance with Technical Appendix Schedule G of the Motorsport Australia Manual. Fuel is not available at the circuit.
- b. The maximum amount of fuel to be stored in each garage is 250 litres. Refuelling is not allowed in pit lane or in pit garages whilst participating in a race.

#### 22. INSURANCE

- a. Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the motorsport Australia Insurance Handbook, available at <a href="https://www.motorsport.org.au">www.motorsport.org.au</a>
- b. Insurance Cover is provided by Motorsport Australia. Advice provided by Motorsport Australia and Historic Sports & Racing Car Association of NSW Inc. #### 23. PROTESTS

a. Any protest must be lodged in accordance with the NCR.

#### 24. GRAND PARADE & PASSENGER RIDES

This Event may include:

- (i) A Grand Parade, which will be conducted in accordance with the NCR; and/or
- (ii) A Demonstration which will be conducted in accordance with the NCR; and/or
- (iii) A Motorsport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy

## 25. INTEGRITY,

- a. Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.
  - Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at <a href="www.motorsport.org.au">www.motorsport.org.au</a>. Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.
  - Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day
- b. Pit lane speed limit shall be 40 kph.

#### **26. GARAGES / CARPORTS**

a. GARAGES / CARPORT will be available for hire at a cost of \$200/\$240 for garage or \$155 for carport spaces. Cars will be allocated to garages and carports according to their requirements and preferences as far as these can be done conveniently.
